

3-Year Premium Consumer Warranty (181002)

AVACEN Medical ("AVACEN") warrants to the initial purchaser ("Purchaser") that each certified AVACEN device ("Product") purchased directly from AVACEN will be free from defects in materials and workmanship under normal use for a period of 36 months from the date of its initial shipment to the Purchaser, or 2400 hours of use, whichever comes first. Any Extended Warranty that is purchased from AVACEN extends the terms of this Warranty as specified in the Extended Warranty terms and conditions. Repair or replacement of products (or parts thereof) under this Warranty does not extend the Warranty period. Use without the AVACEN Mitt will void the warranty.

The obligations of AVACEN under this Warranty shall be limited to repair or replacement (at AVACEN's option) of any product (or part thereof) under Warranty that AVACEN reasonably determines to be covered by this Warranty and to be defective in workmanship or materials. AVACEN shall determine whether to repair or replace products and parts covered by this Warranty. All products or parts replaced shall become AVACEN's property. In the course of Warranty service, AVACEN may, but shall not be required to, make engineering improvements to the warranted products or parts.

Prior to shipping your AVACEN device for repair under this Warranty Purchaser MUST call AVACEN at (888) 4-AVACEN (888-428-2236) and select "Customer Service" or email: support@AVACEN.com to obtain a Return Merchandise Authorization (RMA). REPAIR RETURNS WILL NOT BE ACCEPTED WITHOUT A RMA.

Products shipped to AVACEN by the Purchaser under this Warranty shall be suitably packaged to protect the product. If the Purchaser ships a product to AVACEN in unsuitable packaging, any physical damage in the product upon receipt by AVACEN (and not previously reported) will be presumed to have occurred in transit and will be the responsibility of the Purchaser. Risk of loss or damage during shipment under this Warranty shall be borne by the party shipping the product.

This Warranty shall be invalid if the warranted products (or parts thereof) have been subject to misuse, neglect, or accident; have been damaged by causes external to the warranted product; have been affixed to any nonstandard accessory attachment; have had the serial number removed or made illegible; is used for rental, military or commercial purposes; or have been disassembled, modified, serviced, or reassembled by anyone other than AVACEN, unless authorized by AVACEN.

AVACEN will not be responsible for the effect on safety, reliability, and performance of the product if:

a) assembly, extensions, readjustments, modifications, or repairs are carried out by anyone other than AVACEN or persons authorized to perform repair service on AVACEN's behalf; or b) the electrical installation does not comply with the requirements of the applicable national and international standards, including requirements of the IEC; or c) the product is not used in accordance with AVACEN's instructions for use.

AVACEN SHALL NOT BE LIABLE FOR ANY INJURY, INCIDENTAL, SPECIAL, OR CONSEQUENTIAL LOSS, DAMAGE, OR EXPENSE (INCLUDING WITHOUT LIMITATION LOST PROFITS) DIRECTLY OR INDIRECTLY ARISING FROM THE SALE, INABILITY TO SELL, USE, OR LOSS OF USE OF ANY PRODUCT.
